

11.Organizing of Teaching and Learning

The organizing of teaching and learning for the Bachelor of Political Science Programme in Governance will conduct as bellow:

- One academic year consist of two semesters (there is a summer break);
- One semester consists of 20 weeks: learning in the classroom for 16 weeks, reviewing and examination for 2 weeks, spare holiday for 1 week and semester break for 1 week;

It learns various types of tax collections, calculating of taxes, various tax measures for violators of customs and taxes, obligations of person, legal person and institutions that practicing their business in Laos which must pay their tax to the government. The customs and taxation law focuses on the direct and indirect tax payments which defines in the customs and taxation law such as business turn over tax, excise tax, income tax, minimum tax, and profit tax. Learning about customs and taxations can be used for counselling and applying in daily routines.


