On behalf of the Faculty of Law and Political Science, National University of Laos, the Dean would like to inform you that the FLP will conduct **“The 5th National Socio-Legal Research Forum on the Law Enforcement**, which will take place on 15th December 2023.

The objectives of the forum are to broaden understanding of legal research and promote the legal research guidelines. This event will enable the diversity of the participants to exchange the legal research skills and capacities. This forum shall be also foreseen as the platform for legal researchers to present their academic papers.

Therefore, the Dean of the FLP of NUOL, would like to take this opportunity to invite researchers, lecturers and related officials from your organization who would be interested in presenting in this forum to submit a research abstract and full paper. The applicant's proposal should fall into one of these following sub-themes:

1. Rule of Law
2. Linkages between Law and Social-Economic Development;
3. Law regarding the Environment, Business and Investment;
4. Human Rights and Gender;
5. Other related papers to Law and Development can exceptionally be considered;

The applicant must commit to:

- Submit an abstract (Max. 400 words) in English or Lao;
- Submit a full paper;
- Present the research paper at the 5th National Scio-Legal Research Forum

Abstract:

- Papers in English shall use Time New Roman font; Size 12pts; After Spacing: 6pts; Line Spacing: 1.15pts.
- Papers in Lao shall use Phetsarath OT font, Size 12pts; After Spacing: 6pts; Line Spacing: 1.15pts.
- Abstracts should consist of 400 words maximum (1A4 page) which ought to contain the following:
 1. Title of Research Paper;
 2. Name of author, workplace and email address (for future contact)
 3. The abstract should include:
 - 3.1. Problem statement and Rationale;
 - 3.2. Research Methodology;
 - 3.3. Research findings (so far);
 - 3.4. Recommendations and Solutions (if any)

The interested applicant should send the abstract in Word file to the following email address: researchflp@gmail.com by **20th November 2023** at the latest.

Full Papers:

Following the guidelines of the abstracts, full papers must be submitted to the following email address: researchflp@gmail.com by **1st December 2023** at the latest. Full papers should contain the following sections:

- Title of Research Paper
- Introduction
- Literature Review
- Framework and Research Methodology
- Research Findings
- Analysis
- Conclusion
- Bibliography

Full papers must be minimum of 3000 words (excluding references) in length.

Venue of the Forum:

At Donenoukhoum Campus, Faculty of Law and Political Science of National University of Laos. The forum will be free of charge and is open to the public. Academics and Researchers are encouraged to attend. Coffee break and lunch will be provided for all participants.
